Most recently, Vickie worked as counsel at the US House of Representatives, where she represented Congressional staff in workplace fairness issues relating to their employment either with a Member of Congress or a Committee at the US House of Representatives. In her role, she negotiated settlements and/or represented clients with claims before the Office of Congressional Workplace Rights. She also provided advice and representation to clients regarding filing complaints with the House Committee on Ethics against their employer for violations of Congressional ethics codes relating to workplace issues.
