Faulk v. Dimerco Express

An Atlanta jury has returned a **\$3.39-million-dollar verdict** in a case of employer "race-matching," *Faulk v. Dimerco Express*, Northern District of Georgia, Atlanta Division, Case No. 1:21-cv-01850-MLB. Race-matching is a tactic of hiring employees who racially match the market the company is targeting.

In the case of Dimerco Express, attorneys **Amanda Farahany** and **V. Severin Roberts** of Barrett & Farahany presented evidence that the company was indeed participating in race-matching. They were only hiring Caucasian employees between the ages of 26 and 40 to cater to what the company called the "Caucasian market." This meant that one applicant, Kenny Faulk, was denied a position as a sales executive because of his race, rather than because he didn't have the skills to perform in the position.

The evidence was in Dimerco Express's own emails that they used the tactic of race-matching, proving prejudice in the hiring process. Further evidence showed that Dimerco's Atlanta sales manager wanted to hire Mr. Faulk because he believed he had the skills and experience required. It was when the company president found out Mr. Faulk was black that he vetoed the hiring. **Read more...**
